Information on the processing of personal data ex art. 13-14 EU Reg. 2016/679

Stakeholders: Video surveillance stakeholders.

Nuova Faos S.r.l in its capacity as Data Controller of your personal data, pursuant to and for the purposes of EU Regulation 2016/679 hereinafter 'GDPR', hereby informs you that the aforementioned legislation provides for the protection of data subjects with regard to the processing of personal data and that such processing will be based on the principles of correctness, lawfulness, transparency and protection of your confidentiality and your rights.

Your personal data will be processed in accordance with the legal provisions of the aforementioned legislation and the confidentiality obligations therein.

Purpose and legal basis of the processing: in particular, your data will be used for the following purposes necessary for the pursuit of the legitimate interest of the data controller:

- the retention of the recording is limited to a few hours or, at most, to the twenty-four hours following the recording, without prejudice to
 special requirements for further retention in connection with holidays or the closure of offices or establishments, as well as in the event of a

- The video-surveillance system is introduced as a complementary measure aimed at improving security inside or outside buildings or facilities where production, industrial, commercial or service activities are carried out, or with the purpose of facilitating the possible exercise, in civil or criminal proceedings, of the right of defence of the data controller or of third parties on the basis of useful images in the event of unlawful acts. Purpose of processing Protection of company assets.

Method of processing. Your personal data may be processed in the following ways:

- processing by means of electronic computers;
- use of data for consultation only.

All processing is carried out in compliance with the methods set out in Articles 6, 32 of the GDPR and through the adoption of appropriate security measures.

Your data will only be processed by personnel expressly authorised by the Controller and, in particular, by the following categories of authorised personnel:

• all natural persons, in charge of the processing, authorised to use the facilities and, in cases where it is indispensable for the purposes pursued, to view the recordings have been designated in writing (Article 30 of the Code).

Communication: your data may be communicated to external parties for the proper management of the relationship and in particular to the following categories of Recipients including all duly appointed Data Processors:

 external supervisors and appointees have been designated, since the external body performs services that are instrumental and subordinate to the data controller's choices concerning the management of video surveillance.

Dissemination: Your personal data will not be disseminated in any way.

Retention Period. We would like to inform you that, in accordance with the principles of lawfulness, purpose limitation and data minimisation, pursuant to Article 5 of the GDPR, the retention period for your personal data is:

- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the mandatory time limits prescribed by law:
- established over a period of time not exceeding the fulfilment of legal obligations and for protection in litigation.

Data Controller: the Data Controller, in accordance with the Law, is Nuova Faos S.r.I (Via Togliatti n. 21/1, 61122 Pesaro (PU), P. IVA 02466620412) in the person of its legal representative pro tempore.

You have the right to obtain from the data controller the erasure (right to be forgotten), limitation, updating, rectification, portability, opposition to the processing of personal data concerning you, as well as in general you may exercise all the rights provided for in Articles 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

EU Reg. 2016/679: Arts. 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the Data Subject

- 1. The data subject has the right to obtain confirmation of the existence or non-existence of personal data concerning him/her, even if not yet recorded, their communication in an intelligible form and the possibility to lodge a complaint with the Supervisory Authority.
- 2. The person concerned has the right to be informed:
 - a. the origin of personal data;
 - b. the purposes and methods of processing;
 - c. the logic applied in the event of processing carried out with the aid of electronic instruments;
 - d. the identification details of the holder, the persons responsible and the representative designated pursuant to Article 5(2);
 - e. of the entities or categories of entity to whom or which the personal data may be communicated or who or which may become aware of them in their capacity as designated representative(s) in the territory of the State, data processor(s) or person(s) in charge of processing.
